

Solutions Personal Contract Plan

You never know what the future may bring, so a finance plan with more flexibility may be just what you need. Whether you're hoping to upgrade to a higher specification model in the future, need to reduce your outgoings or even plan to return your Audi, you should consider Solutions Personal Contract Plan.

Your regular repayments are fixed. You defer the payment of a portion of the car's current value until the end of the agreement, so that your monthly repayments are lower than the comparable Hire Purchase option.

- You choose a repayment period (from 18-48 months) and estimate your annual mileage
- ► A portion of the car's value is deferred. This then becomes your optional final payment
- Based on your deposit, which could be as low as one repayment in advance, we'll work out your regular fixed repayments
- ▶ At the end of the agreement you have three options:
- ▶ Option 1 Part-exchange for a brand new Audi on a new Solutions Personal Contract Plan agreement
- Option 2 Pay the optional final payment and own your Audi*
- ► Option 3 Return your Audi, with no further payment^

Hire Purchase

If you already know you want to own your car at the end of your finance plan and want regular monthly repayments to make budgeting easier then Hire Purchase could work for you. You simply put down a deposit and the remaining balance is divided equally over the term of the loan.

- You choose the repayment period (from 12-60 months) and determine the monthly repayment to suit your budget
- You'll pay an initial deposit (typically 10%)
- ► The remaining finance is then equally divided over the term of the agreement
- ► After the last repayment has been made (including the option to purchase fee) you will then own your Audi

Contract Hire

If you're interested in hiring your Audi, then Contract Hire may be perfect for you.

Contract Hire allows you to drive away an Audi without needing to own it, making it perfect for both personal and business customers. It's ideal for customers who simply want to pay a monthly rental for the vehicle or change it on a regular fixed period. You won't ever own the vehicle, so you just have to hand it back at the end.

You'll also benefit from Driverline, a dedicated 24-hour telephone service designed to help you when you need assistance.

Once you have chosen your vehicle and initial rental, there are three simple decisions to make that will effect your monthly rental repayments:

- Your rental repayment period choose any period between 12-48 months
- Mileage per year choose how many miles you expect to drive each year*
- Servicing choose to include a service, maintenance and tyres plan in your agreement

When all outstanding rentals are paid, you simply hand your vehicle back, subject to fair wear and tear and excess mileage charges. There is no additional final payment at the end of the agreement.


