

- **3.** Set your deferred amount (the optional final payment) to lower your monthly repayments.



Fixed-price service plan (pay now)

This is a straightforward, practical way to care for your car. By fixing your servicing costs up front, you're protected if parts and labour prices rise.

There are two plans to choose from:

- > New cars 3 years or 30,000 miles (whichever comes soonest)
- > Used cars 2 years or 20,000 miles (whichever comes soonest)

If you decide you want to sell your ŠKODA a service plan is fully transferrable, making it even more attractive to potential buyers.
